Deemed contracts

If your business moves into premises that are supplied by us but haven't yet agreed a contract with us you'll be placed on our 'deemed contract'.

You can, of course, set up a contract to suit your needs at any time, just call us on **0800 389 4466**. In the meantime, here are the details that apply to deemed contracts.

Understanding our 'deemed contract' rates

As part of our commitment to being open and honest, customers whose premises are placed on 'deemed contracts' are not required to provide a Termination Notice and are free to move to a supplier of their choice at any time.

Deemed contract rates for business electricity and gas

As part of our license agreement and under our Standard Terms & Conditions of Supply, we are obliged to give notice of our deemed contract rates. The deemed rates will apply where a customer remains supplied by SSE but has not agreed a new contract.

How do I know if deemed rates will be applied to my account?

You will have received a letter from us informing you of the impact of not agreeing a new contract with SSE and the timescales in which you have to take any appropriate action. As well as any action that you must take you should also refer to the Terms and Conditions of Supply issued with your current contract.

NB: SSE does not offer deemed prices for EUC bands 4 to 9, these are dealt with as 'priority customers' due to the size and type of supply, and will be priced accordingly. New contracts must be agreed in order for each supply to continue.

Priority customer

In accordance with the Network Code, any customer with an Annual Quantity (AQ), or Aggregated AQ, greater than 732,000 kWh may have a priority customer rating, and will be categorised as follows;

Category A – those for whom disruption to Gas supply could cause loss of life (largely hospitals and care homes). These customers can continue to use gas for the duration of the shortage (unless the gas network has to be completely shut down).

Category B – customers that would be category A but for the fact they are on interruptible contracts (because they can switch to alternative fuels) they should be allowed to continue to use gas for as long as it takes to switch to those alternative supplies.

Category C – customers for whom disruption to gas supply could cause in excess of £50m damage to their plant. They can only continue to use gas for the time it takes to close down the plant.
