With SSE Protect, you'll know exactly what you're paying for from the start. We remove the risk of mid-contract price increases, by fixing your energy costs and non-energy charges for your contract term.

Suppliers have to forecast future price increases to non-commodity elements which are not yet set by third parties and these have to be passed on to customers. This includes the cost of transporting electricity through the different networks.

With SSE Protect, we'll guarantee a fixed level of non-commodity charges in the contract for up to three years, when you have or install a smart meter.² Committing to a fixed rate for the duration of your contract provides reduced risk, price stability and peace of mind.
